

# Safety, Health, and Environment (SHE) Policy

At Equipprotek Energy, we are committed to conducting our operations in a manner that ensures the safety, health, and well-being of our employees, contractors, and the communities in which we operate. We are equally committed to protecting the environment and maintaining the highest standards of sustainability in the oil, gas, and energy industry.

#### Scope

This Policy applies to all Equipprotek Energy operations, including our employees, contractors, and visitors, across all locations and facilities, whether onshore or offshore.

#### **Policy Statement**

#### 1. Safety First

- We prioritize safety in all aspects of our operations. We believe that all accidents and injuries are preventable and strive for a zero-incident work environment.
- All employees and contractors are empowered and required to stop work if they observe unsafe conditions or practices.
  - We continuously identify, assess, and mitigate risks to prevent accidents and injuries.
  - Report immediately, all incidents, Near Miss or Hazard to employee's Supervisor.
- In case of an injury, employee must report to Supervisor and then the Medic on Duty or at a nearest Clinic or hospital.
- All hazards must be minimised or mitigated if not fixed, before reporting the hazard filling in a STOP Cards or other available way at the facility.
- Employees MUST adhere to our Partner's Safety Policies while on duty at the Partner's facility.

#### 2. Health and Well-being

- We are committed to promoting the physical and mental health of our workforce. This includes providing a safe and healthy work environment, as well as access to health services and wellness programs.
  - We actively monitor and manage occupational health risks associated with our operations.
- We promote a culture of well-being, encouraging work-life balance and supporting mental health initiatives.

#### 3. Environmental Stewardship

- We are committed to minimizing our environmental footprint and preventing pollution. This includes responsible resource management, waste reduction, and minimizing emissions.
- We adhere to all relevant environmental laws, regulations, and industry standards, and we aim to exceed these requirements wherever possible.



- We actively seek innovative solutions and technologies to reduce our impact on the environment and support global sustainability efforts.

#### 4. Compliance and Continuous Improvement
